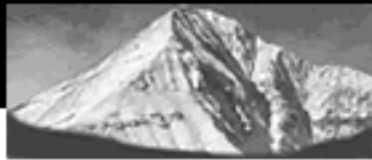


UNDER THE BIG SKY GREENING CONFERENCE

Early registration of \$125 is accepted until May 16. After May 16, registration is \$175. Fee includes:
